People Helping People

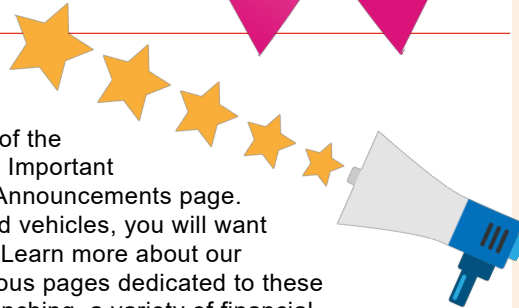
Throughout the month of October, TFCU employees will be raising funds in honor of Breast Cancer Awareness Month.
