Gibbons Inducted into MS Credit Union Hall of Fame

TFCU President and CEO John Gibbons. Jr. was inducted into the Mississippi Credit Union Hall of Fame at the MSCUA 2024 Annual Meeting, held on May 15th in Biloxi, MS. This award recognizes Gibbons' impact and leadership during his 37 years as the credit union's top executive. Hired in 1987 as President/CEO of what was then Columbus Air Force Base FCU, he has propelled Triangle FCU forward throughout the years, with assets surging from \$10 to \$110 million under his guidance.

As the MS Credit Union Association's most tenured director. Gibbons has been a beacon of dedication

to Mississippi's credit union movement. Elected to the MSCUA Board of Directors in 1990.

he has held the offices of secretary/treasurer, vice chairman, and chairman, and has served on and chaired numerous board committees. His commitment to the peoplehelping-people credit union philosophy is unwavering.

Foster Inducted into Triangle FCU Hall of Fame

TFCU Director Ron Foster was inducted into the Triangle FCU Hall of Fame at the 2024 Annual Meeting, held April 24th in Columbus. Foster was first elected to the TFCU Board of Directors in 1982 while stationed at Columbus Air Force Base, where he was Command Chief, responsible for all enlisted personnel. In 1985, after 30 years of military service, he retired from the Air Force as a Chief Master Sergeant. Mr. Foster continued his career at CAFB working in Civil Service for 15 years, culminating in a 45-year career with the U.S. Government.

Mr. Foster has served as a delegate for the Defense Credit Union Council, the National Association of Federal Credit Unions, and the MS Credit Union Association. He has served TFCU as past chairman and currently serves as chairman of

the ALM Committee. He has proven himself a dedicated leader and has set the highest standards for Volunteers and staff.

For the past 42 years, Mr. Foster has always been there for TFCU, attending nearly every board meeting, training seminar, and planning session. In 2019, he was inducted into the MS Credit Union Hall of Fame. He is the epitome of the well-known motto, Service Before Self. He is pictured with his wife, Kathy.
