After 38 years of dedicated service and exemplary leadership, John Gibbons, Jr. retired as President/CEO of Triangle FCU on December 31st, 2024. Under his guidance, the credit union grew from approximately \$10 million in assets to more than \$110 million, and from one location to five. Mr. Gibbons also served as the Mississippi Credit Union Association's most tenured director, having been elected to the Board of Directors in 1990. In May of 2024 he was inducted into the Mississippi Credit Union Hall of Fame, the highest credit union honor bestowed upon an individual within our state.
